CAFE LAUREN AND BURKE STREET CAFE OPERATE AT OUR MANCHESTER AND NASHUA GIRLS CENTERS, RESPECTIVELY. BOTH DINNER CAFES ARE OPEN FROM 4:45 PM TO 5:30 PM EACH EVENING FOR HOT MEALS.
